If Not for CASA, then Who?

Have you ever thought about what the child welfare landscape would look like without CASA? We speak often about the gratitude we have for our volunteers, and the very real, tangible difference they make in the lives of the children we serve, but what would it look like for these children, if not for CASA?

Before Court Appointed Special Advocates existed, Seattle Superior Court Judge David Soukup often felt frustrated at not having detailed information that he needed to make informed decisions regarding the welfare of children in care. In 1977, he created the first CASA program.

48 years later, and our incredible volunteers are still practicing whole child advocacy while giving judges a glimpse into the real-life circumstances of the young person behind a child's name and cause number. Without the work of their Court Appointed Special Advocate, very real needs would go unmet and vital details slip through the cracks.

CASA Court Reports provide our judges with detailed information they need to make decisions that they often do not receive from other sources. Because of this, children are safer and families receive more of the services they need. Our Advocates view the whole picture, and think 'outside of the box' when it comes to meeting the needs of the whole child.

CASA plays an integral role in advocating for a child's educational needs, medical needs, and most importantly, ensuring that they are safe physically and emotionally. Our volunteers undergo extensive training prior to swearing in, with an additional 12 hours of continuing education every calendar year. They volunteer countless hours of their time to immerse themselves

in the lives of the children they've committed to serve. It is impossible to quantify the impact they make daily, and we are so thankful they do what they do.

CASA Across the Nation in 2025

In 2025, the National CASA/GAL Association reports that their programs serve approximately 200,000 children annually, a figure based on their most recent annual impact reports. The exact number for 2025 may fluctuate, but the organization consistently works to serve a significant portion of the children in the dependency system, with a goal of providing a trained advocate for every child who needs one.

- The organization's most recent available annual data indicates they serve about 200,000 children.
- They work with more than 79,000 volunteers.
- CASA/GAL programs are active in 49 states and the District of Columbia.
- The organization aims to serve every child in the dependency system with a trained volunteer.




Logging CFE Tools – What to Log and How?

By now, you've had training on CFE tools like Connect Cards, Circles of Trust, and Mobility Mapping. You've been trained on how to log those events into Optima, but did you know that your CFE work goes way beyond Family and Team Meetings, and utilizing those tools?

As CASA, you spend a lot of time interacting with a child's family, as well as having heart-to-heart conversations with children about family relationships and memories. Those connections are the HEART of CFE! Next time you are compiling and entering your notes after a child visit or family interaction, be sure and add each one of them to the Family/Child Connections or CFE Tool section of your contact logs as well. If you're unsure of how to copy/paste an entry into multiple categories, please reach out to your Volunteer Coordinator or the Office for help!

It is vital for grant purposes that the hard work you're doing in CFE is documented – but beyond that, the hard and heart work you are doing should always be accounted for!





TBRI® Caregiver Training

In 2025, CASA Hope for Children was pleased to offer TBRI® Caregiver Training to staff at both the Children's Advocacy Center and OCOK of Parker County. Aside from that, we've been working hard to offer Caregiver Training to Kinship Placements, Foster Families, and parents who are either approaching or in the midst of a Monitored Return. Once placements have completed the Caregiver Training, they are offered ongoing coaching sessions with one of our TBRI® Practitioners. These coaching sessions offer more in-depth discussion of trauma-based behaviors and providing trauma-informed care. We are committed to helping Caregivers be successful in providing a healing and nurturing environment for the children we serve.

As we approach 2026, we look forward to offering our first TBRI® Caregiver Training to our community, as well as regularly offering this training to every one of our Advocates. We are so happy to have received wonderful feedback from those who have attended the training and coaching sessions alike and have seen real change manifested in the parenting approaches our trained Caregivers are taking. This training has the potential to maintain placements, strengthen the connections between parent and child, and educate every professional working with our children in best practices.




It's All About Connection

Safety Advocacy - What to Look For

As Court Appointed Special Advocates, advocating for a child's safety includes visiting them in their placements and acting as a 'detective' of sorts to determine whether their needs – physical and emotional – are being met. The area of Safety Advocacy can seem rather simplistic – however there are subtleties that we look for beyond the obvious to ensure that the children we serve are safe.

We may have a vision in our minds of what a safe home looks like – sanitary, free of clear hazards, with the child having safe and appropriate places to sleep and play. While those are certainly




important factors, any child involved with the child welfare system has undergone significant trauma in their past and needs an emotionally safe place to heal and grow.

Is the child you're visiting eating the same meals and snacks as the other children in the home? If there are no dietary restrictions or preferences being considered, yet the child you're visiting is eating peanut butter and jelly while others in the home are eating a special meal, that bears investigating further. If the child on your case is wearing worn and ill-fitting clothing, and lacks basic hygiene items, we must consider whether that placement needs additional resources. Is the child on your case involved with their placement's at-home and extracurricular activities, fulfilling their right to normalcy, or do they seem isolated from what others in the home are doing? If any of these concerning circumstances are apparent, it's important to investigate further and resolve with the rest of the child's team whether this placement can become safe and appropriate.

Does the child's placement appear to be trauma informed and aware of their mental health and emotional needs? Are there additional services that could be offered to the placement to help equip them to effectively care for a child with trauma-based behaviors? CASA Hope for Children offers both TBRI® Caregiver Training and ongoing TBRI® Caregiver Coaching services, to help every placement become knowledgeable around meeting the emotional needs of children from hard places.

When you have questions or concerns regarding the safety of the children you serve in their placement, we are here for you! Contact your Volunteer Coordinator – you are the eyes and ears of our organization, and your work is vital!
